1	Module 5: Dissemination and Implementation	Welcome to Module 5 of the Evidence Analysis Center Orientation Tutorial. This is the last module in the series designed to help acquaint you with the Academy's Evidence Analysis reviews and guideline. This module will cover the Academy's process to disseminate and implement the guidelines.
2	Module 5 Objectives	Upon completion of this module, you will be able to − ✓ Understand how the Academy disseminates an Evidence Analysis Center review or guideline. ✓ Learn how to implement an Evidence Analysis Center guideline ✓ Learn about different resources generated from the Evidence Analysis Center content.
3	Guideline Dissemination	Let's review how the Academy disseminates results once a scoping review, systematic review, or guideline is complete.
4	Promotion	Following the publication of an Evidence Analysis Center review or evidence-based nutrition practice guideline, the Academy executes a plan for dissemination of the findings and implementation into practice.
5	Evidence Analysis Library	The EAL is the primary source of dissemination of Academy systematic reviews and evidence-based nutrition practice guidelines. The EAL has received over 24 million-page views and has been accessed in over 200 countries and geographical areas. Users include Academy members, individual subscribers and group subscribers such as university libraries, government agencies, and international dietetic associations.
6	Journals	Once the scoping review, systematic review or guideline has been finalized, the expert panel starts to develop a manuscript for publication in the Journal of the Academy of Nutrition and Dietetics and other topic-related peerreviewed journals. This helps ensure wide dissemination of the results and implementation of the recommendations.

7	EAC Framework	By now you are familiar with the EAC Framework. Once the systematic review is complete, the project team address the question "Is this topic controversial, confusing, important for policy or requires clarification? If this answer is 'yes', and the evidence was graded I (Good) or II (Fair), they can develop an Academy Position Statement. If the answer to the question was Yes but the evidence received a Grade III (Limited), the expert panel can develop a Consensus Report.
8	Academy Position	Here are 2 examples of recent positions. The first is from the Nutrition Screening Adults systematic review. The expert panel developed a position statement based on good evidence from the review. The Nutritional Genomics expert panel were unable to develop a position statement because the evidence was limited. Since the topic was confusing, controversial, and important for policy, they developed a consensus report to be published in the summer 2020.
9	Presentations	These power point presentations are a great way to disseminate a guideline. They include the guideline recommendations and ratings and are ideal for meetings and training members of your healthcare team to implement the recommendations. They are not designed for the consumer or patient.
10	Social Media	The Academy uses its social media platforms to disseminate important findings. Follow us on Facebook, Twitter, and Instgram.
11	Academy Resources	The Academy incorporates important research findings in many resources such as the Nutrition Care Manual, books and pocket guides, webinars and much more. These resources help implement the recommendations. Visit www.eatrightstore.org for additional information.
12	Mobile Application	The Academy developed NutriGuides – a mobile application. The app contains over 400 EAL recommendations and is searchable by disease / condition; topic or NCP step. It is available from iTunes or Google store and sells for \$1.99
